Prior to completing the official **TI Best Rate Guarantee (BRG) Claim Form** on the following page, please be sure to review these **TERMS & CONDITIONS**.

- 1) If you find a lower price, on any website based in the U.S.A., for a room or suite (that includes the exact same dates, room or suite type, number of guests, added valued (if applicable), tax percentage and/or resort fees, etc.), or show tickets (for the exact same performance date, time, tax percentage and/or fees, etc.), and submit an official TI BRG Claim Form within 36 hours after confirming reservations with Treasure Island (confirmation number required), TI will honor the lower pricing as well as provide you with two (2) complimentary buffet vouchers to use during your stay (i.e. vouchers expire at check-out).
- 2) Honoring the lower price would apply, but complimentary buffet vouchers are **NOT** applicable to non-hotel guests as well as those cases where the lower or equal price is available directly from the TreasureIsland.com website or TI Room Reservations call center.
